9.00 — Welcome and opening remarks from Peter Berry, EEA Executive Director



Judy Nicholl's commitment to safety is central to her CEO role at Counties Energy. However she also has a very personal commitment to care deeply about safety: a serious road accident took her, in the blink of an eye, eight years ago, from being able to run to having to slowly heal her way back. It was a road accident caused by one of the most common causes of accidents in the workplace: distraction.

At Counties Energy, this commitment to safety remains front and centre, because Counties Energy teams work directly with electricity, work at heights, work at risk of slips and falls, and have to manage safety risks constantly. Safety leadership is everyone's job, and, as CEO, Judy's job means she focuses on safety across the company and the Counties Energy community served by the network. She has worked in multiple industries that operate in high-risk environments – aviation, meat processing – but believes that, regardless of the industry, we must think clearly, without distraction, to manage safety risks and believe that every accident is avoidable.



Greg Skelton is Chief Executive Officer of Wellington Electricity Lines Limited and has been with the company since its formation in 2009. Greg has over 30 years of experience in the fields of production engineering, electrical engineering and business management. He holds a Bachelor's degree in Electrical Engineering, a Master's degree in Business Administration, and is a Fellow of Engineering New Zealand.

1.00pm — Psychosocial Risk Management for NZ Electricity supply providers | Georgi Toma, Director Heart and Brain Works



Dr. Georgi Toma is an expert in stress, burnout, psychosocial hazards and workplace psychological health and safety. She is the founder of Heart and Brain Works, a consultancy that offers a comprehensive solution for mental health at work. She is also an honorary research fellow at the University of Auckland, where she conducts research on wellbeing at work.

She has worked with organisations such as RMIT University, Hitachi Energy, Christchurch City Council or Environment Canterbury to create healthy work environments and equip their staff with the skills required to thrive.

She is the creator of The Wellbeing Protocol, a scientifically-validated program to reduce burnout and improve mental wellbeing in the workplace. Research studies show that the Wellbeing Protocol can help employees reduce stress by up to 58%, burnout by up to 60% and improve mental wellbeing by up to 103%.
